

- 3) Further action may be taken to require employees to participate in provided education and training, obtain proof that facility equipment is operating properly, and that disease control prevention procedures are being followed. In cases where the facility continues to operate out-of-compliance, a *Cease and Desist Order* or similar injunction may be requested/issued by the county board of health. (CRS 25-4-1610)
- A Prior to closure, formal notice will be provided. You will be given a reasonable amount of time to comply with the Regulations.

 You are entitled to enact the grievance process pursuant to section 25-4-1609.5, C.R.S. at any time during this process.
