## **DELTA COUNTY COVID-19 UPDATE**

Delta, Colorado (November 29, 2021): Delta County COVID-19 Informational Update

COVID-19 continues to spread in Delta County. From Tuesday, November 23, 2021 through today, Delta County has seen 89 new cases for a total of 4,563. Delta County's positivity rate sits at 9.6 %. Delta County Health Department continues to strongly encourage all Delta County residents to get vaccinated, wear a mask in indoor settings and large gatherings, to wash your hands thoroughly and often, to stay home if you aren't feeling well—and get tested!

Delta Health has 10 individuals hospitalized with COVID-19; their ICU bed utilization is at 33%. Delta Health wants to continue to remind all residents that, if you have recently been diagnosed with COVID-19, and are at an increased risk of becoming seriously ill and / or being hospitalized, to please contact your physician regarding the possibility of receiving a Monoclonal Antibody Infusion treatment. The monoclonal antibody prevents those already infected from getting severe disease.

Delta County Health Department and Delta Health would like to stress the importance of getting the flu vaccine this year, in addition to the COVID-19 vaccine. The Center for Disease Control (CDC) said although flu activity remains low nationwide, over 90% of new cases in recent weeks have involved children and young adults ages 5 to 24. The H3N2 strain accounts for the majority of cases this season. In addition, with regards to the new Omicron variant, vaccines still remain the number one, most effective way to combat serious illness and death, from COVID-19.

Delta County Health Department (DCHD) will offer a pediatric vaccine clinic on Thursday, December 2, from 4:00p -6:00p, at Cedaredge Middle School. It is not necessary to pre-registration, walk-ins are welcome. On Tuesday, December 7, Delta County Health Department will offer another pediatric vaccine clinic at the Hotchkiss K8 school from 4:00p - 6:00p.

The State's COVID-19 vaccine bus will be in Delta County again this week offering 1<sup>st</sup>, 2<sup>nd</sup>, booster and pediatric doses of the COVID-19 vaccine, they will also have the flu vaccine available:

- Sunday, December 5 Delta County Fairgrounds in Hotchkiss– 8:00a 12:00p
- Sunday, December 5 Poulos Park in Paonia 2:00p 5:00p

Delta County Health Department wants to remind everyone that taking care of one's physical and mental wellbeing is crucial, during the holidays and all year long. This time of year can be particularly stressful, but stress relief activities are not helpful if you aren't taking care of yourself. Last is emotional self-care, it's important to have healthy coping skills to deal with uncomfortable emotions like anger, anxiety and sadness.
